### ***2022 EVENT RULES AND PRESENTATION.***

The event will be international in scope and held at a prestigious location. It will be the subject of a large global media advertisement for a maximum attraction of exhibitors and visitors and also to promote many talented artists, professional or not, in different activities.

This exhibition, sorted by theme, will interest a new audience. It comes not to see a particular artist, but a group of artists who have produced works around a world-renowned personality.

At each edition, the exhibition will be based on a different personality from the world of cinema, politics, sport, music or others.

## **EXHIBITION RULES.**

This 2022 edition of **International Personality Art Contest** is open to all professional and amateur artists, regardless of age or nationality, and also to individual owners of works or the galleries. All will be able to present one or more **original and quality works** on the subject chosen for this edition, namely :

Personality retained for the **2022 edition**      **Sir MICK JAGGER**

The artist will offer the portraits of the selected person or objects representing the environment of the said person. **One or more works** can be presented.

The art work may be with the character standing, seated, in action, ..., full-length, half-length, bust, three-quarter profile, ..., individual, group, ... .

This event is for works of art in the **following categories : painting, drawing, photography, sculpture, engraving, caricature, mixed media, decorative arts on and with any medium, textile, glass, wood, stone, metal, ceramic, mosaic, paper or other materials and techniques.**

Duration of the exhibition. This event will be staged for a period of four weeks in a prestigious location in Europe.

## **CANDIDATES REGISTRATION.**

The exhibitor may only present **personal productions**. **An individual or a gallery** can also present one or more original works from their **private collection**. No reproduction will be accepted. Copies, plagiarism or internship work detected will be excluded.

A selection of works will be made on file after sending photographs of the production (s) as well as a brief description (year of creation, title and history). A copy of the property certificate or a certificate of honor will be provided by individuals or galleries for private collections.

To apply, you must complete the attached form and send it by e-mail to **GRAND AIR\* Culture** :

- surname, first name, contact details,
- telephone and mobile number, e-mail address,
- a biography with your artistic background and references,
- for each work, specify the year of creation, a title and a text, – the estimated value, its dimensions and the weight,

and as an attachment to the application, a **good quality visual of the work** and a **ID of the candidate (jpg)**. (Catalog publication)

The artist, the gallery or the individual will establish on the registration form the value of the work. The price must not be displayed anywhere on the object.

We draw your attention to the importance of communicating all this information and the dimensions of your works so that they can be highlighted during their exhibition and with the media.

The portrait can be individual, group or in a specific environment. All types of portraits are accepted as long as the character is identified or identifiable.

Upon receipt, the **GRAND AIR\*Culture** association will confirm by e-mail that the application has been accepted.

**The works will be sent to us with or without a frame, and preferably WITHOUT a frame.**

### ***SELECTION CRITERIA.***

Each application is submitted to a selection jury. The selection will be made by a committee made up of **GRAND AIR\*Culture** members and international art professionals. It will be based on **criteria of quality and creativity** of the works presented.

The jury's assessments will be carried out taking into account the following criteria : visual impact, creativity, harmony of colours or black and white, mastery of light and expression of the subject.

After deliberation, the organizing committee will announce by press release the works selected or not to the artists. The committee's decision is final and can not be contested under any circumstance.

---

### ***REGISTRATION FEES. (only for the selected works)***

After the official press release announcing the works selected, a registration number will be issued. The artist will have to pay a **total registration fee of 50 Euros per file**, for one or more works, to validate his participation.

For exhibitors; there will be the possibility of making a frame on site: 30 Euros per work. Works without chassis must reach us before the date appearing on the schedule of operations (see annex) in order to allow us to order the chassis. We will tell you the shipping deadline. The works will be returned to the artist as received, with or without a frame.

The works must have on the back a label or sticker mentioning the artist's surname and first name as well as the title of the work appearing in the listing on the registration sheet.

The duly completed **registration form** must be returned to us with a proof of your bank transfer (IBAN in the appendix) to the order of "Grand Air" (see operations table in the appendix). The receipt of the transfer will confirm the registration.

## **AWARD GRAND AIR 2022 « International Personality Art Contest (IPAC) »**

These prizes are intended to reveal and **promote talented artists** by giving them the opportunity to evolve in the international contemporary art market. These **prizes consist of 3 (three) cash prizes** paid unconditionally to the winner.

- The first prize in the amount of **1500 (fifteen hundred)** euros.
- A second prize in the amount of 1000 (one thousand) euros.
- A third prize in the amount of 500 (five hundred) euros.

The results and prizes of the **AWARDS GRAND AIR 2022** will be announced at the opening Gala of the exhibition. The 3 winners will be able to attend the presentation of their **prizes and certificates**.

The jury for these Awards is appointed by **GRAND AIR\*Culture**. The members of the jury can be critics and personalities, journalists, museum curators related to the field of art, as well as service providers and partners of the organization.

The prizes rewarding the winners will be payable within 30 (thirty) days following the end of the last exhibition by wired transfer to the bank account of the winners, opened within a financial establishment located in their country of legal residence.

In accordance with the regulations in force, the prize cannot be paid in cash.

---

### **EXHIBITION & SALE.**

The artist, the gallery or the individual will tell us if his or her work (s) **can be purchased** by a visitor during the various exhibitions. The work will only be available to the buyer at the end of exhibition.

After the first contact with the future buyer, the organizer will immediately contact the artist or the individual.

The association will charge a **15% commission** on the amount of the sale and send the artist the payment for the sale within 30 (thirty) days of the end of the event.

Each work must have on the back or underneath a label mentioning the name of the owner. All parts will be labelled.

---

### **INSURANCE.**

The security of the goods and works entrusted will be ensured by the chosen exceptional location for 2022 a casino. This place is protected and guarded by qualified personnel and by video surveillance 24 hours a day, 7 days a week, as well as by the staff of the organization during visiting hours (2:00 p.m. to 8:00 p.m.).

---

### ***TRANSPORT OF WORKS. (Shipping and return)***

The transportation of the works selected for the exhibition is the **responsibility of the artists** from the place of departure to the place of the association's headquarters or to the designated freight forwarder for non-EEC / Schengen Agreement shipments. The precise address will be communicated to you.

The works must arrive appropriately packaged (reinforced elements, rigid rolls, etc.).

Upon receipt and departure of packages at the event site, the association will confirm to the artist by e-mail that the package has been received and in good condition, as well as photographs if necessary.

The events organizing team cannot in any case be held responsible for any damage occurring during transport.

Upon information from the organization (place and date of removal), the artist, the gallery or the individual must, for the return of his or her works, take care of the initial contact with his carrier and indicate the contact details. He will pay the cost of sending to the said chosen carrier.

The return of works must be made to the address of the place of departure.

---

### ***ADVERTISING AND COMMUNICATION.***

Press and public relations are provided by **GRAND AIR\*Culture** and its partners.

**The association and partners** will ensure communication and publicity of the events through the national and international press; by radio, television, posters, flyers, billboards, invitations, website and social networks. Exhibitors are advised to also advertise on their social networks.

The **artists, the individual and the galleries grant** the organization and its partners **the right to reproduce**, free of charge and without limitation of duration, the information presented in their registration file and in all their communications for the purpose of promotion on all medias, electronic or not.

For the various communication supports, you will have to write a short artist's statement with details of yourself as well as each art work. He will also need a photo of you and of the work(s) presented.

---

### ***GENERAL INFORMATION & CONDITIONS.***

The registration confirmation will be on hold until the registration fee payment.

By filling out the registration form, **the exhibitors accept these participation rules** and all the articles included.

Personal data and images sent will be used only for purposes related to the **World Personality Art Contest**.

The participants' data, like the images of their works, will not be sold to third parties.

In the event of force majeure, the Organizing Committee for the event reserves the right to cancel the exhibition without notice. Only the registration fee will be returned. No compensation can be claimed.

The Parties will not be responsible for the non-fulfillment of their obligations in the event of ~~a case of~~ force majeure case, defined as any unforeseeable event resulting from circumstances external to the Parties.

Applicable right. These regulations are subject to French law. Any disputes that may arise between the Organization, the partners and the exhibitor (s) will be submitted to the competent courts of Moselle / France.

As these Rules are translated into several languages from French, the French version is considered to be the reference version in the event of a dispute or possible translation error.

**Participating in the exhibition implies full acceptance, without restriction, of these regulations.**

Artists must send their application, with information and attachments (in jpg format) using the form on the **www.grandair.fr** site.

The application file can be written in the candidate's native language.
